

Supplier Declaration on REACH Compliance

SemiNex Corporation, based on the best available information provided by its suppliers, confirms that its laser components do not contain any of the 235 substances of very high concern (SVHC) specified in the ECHA Candidate List (as of June 2023), in concentrations exceeding the applicable maximum concentration values. This statement is based on our knowledge, information, and belief.

SemiNex Corporation certifies that our products are fully compliant with the requirements of (EC) No 552/2009 of 22 June 2009, which covers the Registration, Evaluation, Authorization, and Restriction of Chemicals (REACH). This legislation aims to protect human and environmental health by regulating SVHCs and restricted substances identified in REACH Annex XVII.

SemiNex Corporation, along with any affiliate responsible for the import of articles into the European Union, provides this communication in accordance with, and only to the extent required by, REACH Regulation 1907/2006. Compliance is ensured through the careful selection of components and materials. SemiNex is a manufacturer of "ARTICLES" for our EU customers, according to ECHA's guidance. SemiNex does not manufacture "substances" or "preparations," and our articles do not involve the "intentional release of substances." Accordingly, we foresee no registration, pre-registration, or authorization requirement for the products we supply.

- 1. Regarding Article 33 of REACH: There is a duty to communicate information on substances in articles. SemiNex declares that none of the SVHCs (the Candidate List of Substances of Very High Concern for authorization, as released by ECHA in June 2023) are present in any of SemiNex's products in quantities equaling or exceeding a concentration of 0.1%.
- **2.** Regarding Article 67 of REACH: A substance on its own, in preparation, or in an article, for which Annex XVII contains a restriction, shall not be manufactured, placed on the market, or used unless it complies with the conditions of that restriction. SemiNex declares that none of the substances in the Conditions of Restriction are present in SemiNex products.

Commitment to Compliance and Safety:

SemiNex is committed to ensuring that all our products and packaging meet applicable environmental legal requirements. We are dedicated to reducing the use of potentially hazardous substances in our products and packaging to minimize any potential risk to human health and the environment. However, SemiNex assumes no liability for product compliance with regulatory requirements that change after a product has been supplied to the customer.

The exposure to a user and the risk of physically contacting any listed SVHC through normal usage of our products is extremely low. The substances listed do not pose a safety risk to customers. Promptly and thoroughly wash hands with appropriate cleaning products after handling equipment. Dispose of materials according to defined WEEE (Waste Electrical & Electronic Equipment Directive 2012/19/EU) regulations.
