Pursuant to the provisions of the U.S. Dodd-Frank Act, Section 1502 (effective July 21, 2010), and the EU Regulation 2017/821 (effective January 1, 2021), we hereby declare our adherence to these legal requirements as a supplier.

We affirm that the devices, parts, assemblies, components, and other items supplied to SemiNex Corporation, both currently and in the future, are free from conflict minerals originating from the Democratic Republic of the Congo (DRC) or its adjoining countries.

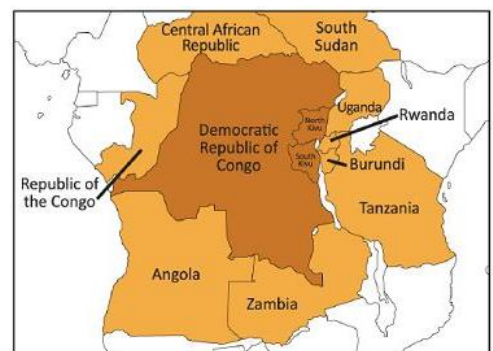
Conflict Minerals within the meaning of the Dodd-Frank Act and EU Regulation 2017/821 are:

Mineral	Description	Material	Important areas of use
Cassiter-ite	Tinstone, Raw material for tin extraction (Sn)	Tin (Sn)	Metal coatings, alloys, use of solder and bronze in soldering processes, circuits and semiconductors.
Columbite-tantalite	Coltan, raw material for niobium and tantalum extraction (Ta)	Tantalum (Ta)	Electronic components including capacitors, aviation and surgical components, use in steel production (niobium), etc.
Gold	Raw material in pure form and as by-product obtained by mining operations	Gold (Au)	Electronics, optics, aviation, IC bondwire, cables, printed circuit boards, electrical connectors, switching contacts, etc.
Wolfram-ite	Raw material for tungsten production (W)	Tungsten (W)	Metallic wires, electrode contacts in lighting, electronics and for various electrical applications, welding applications, alloy component, tool steels

Conflict Regions within the meaning of the Dodd-Frank Act and EU Regulation 2017/821 are:

Democratic Republic of the Congo and neighboring countries (Burundi, Rwanda, Uganda, Central African Republic, South Sudan, Zambia, Angola, Congo, Tanzania)
